#### Free Pancake Breakfast

Special CLA breakfast: The Ladies of the Acworth Meeting House Restoration Project are planning another FREE PANCAKE BREAKFAST for CLA members before the annual meeting on July 4. Starting at 8 AM, at the Acworth Meeting House / Church dining room, the breakfast will include pancakes, bacon, sausage, juice, and coffee—served with a lot of smiles—and donations will be gratefully accepted. All proceeds go to the Restoration Project.

Last year's breakfast raised over \$1500, and along with the many other fundraising efforts organized by the great people of Acworth, it has helped bring the project closer to completion. Some say the steeple might even go back up in June! Come and share in the excitement of this impressive project.

#### **\$\$ Dues Increase \$\$**

The last dues increase for CLA cottage owners was in 2003 when we started the Milfoil project and raised dues from \$10 to \$40 to support the Milfoil Committee's important efforts to preserve the beauty of our lake.

## The Acworth Wild Man

Seems that in March of 1925, the Ben Hawkins family was sitting down to a late Sunday dinner in their home over near the Unity town line when one of his daughters looked up to see a scraggly-bearded man looking in their window. The girl screamed and the men folk went for their guns.

The scary man took off with such speed that the men could not catch him. They noted, however, that he was naked except for a pair of shoes and a short raincoat and was over six feet tall.

At that time the CLA was receiving \$3000 per year from the NH Lakes Association. In 2006 this was lowered to \$2000 because more NH lakes were getting involved in the Milfoil inspection program. This cut back on the amount available for CLA.

This year we were notified that Crescent Lake will receive only \$1500 from the Lakes Association. Fortunately, five years ago we started getting additional funds from the Towns of Acworth and Unity, which helped replace the State funds. On average, about 30 cottage owners per year donate extra money to the Milfoil Fund, for an additional \$1100.

But with this latest reduction, the Milfoil Committee is coming to the CLA membership for a dues increase to take effect in 2010. A \$5 increase will raise about \$700 more. A \$10 increase will raise

\$1400.

The Milfoil Committee strongly recommends that we continue its successful program of inspecting all boats that enter Crescent Lake to keep out invasive weeds that could choke our most precious resource. But in addition to the countless hours donated by our tireless volunteers, the full-time inspection program costs nearly \$10,000 per year.

So please come to the Annual Meeting ready to vote on this proposed dues increase for 2010.

#### Milfoil Committee



They reckoned that he was in his early forties with a dark complexion. He was, they said, filthy. Matted wooly hair covered his forehead and eyes.

Now you can imagine what an incident like this did to a town as small as Acworth.

Mrs. I.W. Mailman did her shopping at the general store while carrying a revolver and told everyone that she was ready to use it.

Emily Jeffery was out in her yard one afternoon when the apparition appeared and scared the wits out of her. She called for her three sons who chased him away.

In the chase, they noted that the man easily vaulted over a five-foot fence on their property. He ran, they said, like a deer with his heavy coat flapping at his knees.

No one, it seems, could catch him. Everyone was trying. And all were scared to death. He was the wildest apparition ever seen in Acworth.

Finally, the townsmen formed a posse and scoured the woods for the man. They found his camp over in North Charlestown.

The waited for the man and captured him without incident.

Historian Frank does not tell us what the name of the wild man was but apparently he was harmless and homeless. He had, the historian states, never committed a crime.

Mr. Caravan has also worked with Sodexo Dining Services and Colby-Sawyer to organize a dinner for veterans from around the country who participate in NEHSA's Winter Sports Clinic for Disabled Veterans. He has also coached Little League baseball teams, directed an elementary school ski program, and played a major role in the creation of Fishersfield Park in Newbury, NH.

"Barry's nature is to be helpful in any way that he can. While he goes about his work around the college, he always has his eye out for the best interests of the students, which carries over to his volunteer activities as well," says Doug Atkins, vice president for administration. "He very much enjoys snowboarding and takes great satisfaction from showing disabled people that they, too, can enjoy the slopes. #### Now What Will We Do?



## Milfoil Committee

Once again, under the leadership of Tim Perry with the excellent assistance of Mark Wilson and the rest of the Milfoil Committee, 2009 has gotten off to a great start. We continue to be extremely fortunate to have a very veteran Lake Host crew returning to man the boat launch. assisted by a couple of highly qualified new hosts as well. It is our Lake Hosts who form the backbone of our efforts to keep invasive water plants (milfoil) out of Crescent Lake. Certainly a large part of our success, to date, stems from the fact that our Lake Hosts come from the Crescent Lake community and take the job very seriously. Thanks to all of them.

In 2008 our Lake Hosts worked from Memorial Day through Labor Day, performing a total of 692 boat/trailer inspections. The typical work day is 10 hours per day during the week and 12 hours per day on weekends. Our goal of educating the boating public that uses Crescent Lake seems to be going very well. I can't begin to stress enough how very fortunate we are to have such a comprehensive program to keep invasive plants, such as milfoil, out of Crescent Lake. During the summer of 2008 two incidences of milfoil were found in Lake Sunapee. One was a piece of milfoil floating at the boat launch in Sunapee Harbor, but a fairly substantial infestation was reported at the State Beach boat launch. It proves that we can never let our guard down and must continue our vigilance.

One other issue should be noted. have seen the funding that we receive from the NH Lakes Association cut. We went from \$3000 in

2007 to \$2000 in 2008 and this year our funding has been cut to \$1500. The Milfoil Committee has, to date, been able to cover expenses with only minor changes to our Lake Host program. We appreciate all of the donations and the special fundraising efforts that have been made on behalf of the Lake Host program.

Stan Rastallis is again heading up our program to survey the lake bottom for weeds, with an eye towards finding any potential problems. Our first goal is to keep invasive weeds completely out of Crescent Lake. Our second goal is to discover invasive plants that may have inadvertently found their way into Crescent Lake. Early detection would be critical in minimizing potential impacts. Thanks for all of the volunteers who assist in this effort, and are willing to take an early swim in the lake while the water is still pretty chilly.

The members of the Milfoil Committee wish to thank all the members of the Crescent Lake Association (YOU) for the support you have provided, and continue to provide, to help with the fight against milfoil and other invasive plants.

## **Conservation News**

Dick and Jane Desbiens have offered the town of Acworth first option to buy an 83 acre parcel located on the south side of Crescent Lake Road bordering the Acworth/Lempster town boundary. They are asking \$123,000 for the 83 acres. If acquired the property must be protected with a perpetual easement preventing it from being developed. The property borders the Acworth Gove Forest which is protected land. If the town acquired the property it could be added to the Gove Forest and be protected and monitored by the town and the Society for the Protection of NH Forests. The Desbiens have chosen to make this offer after considering other options which they felt might not be beneficial to Crescent Lake and the lake community. They are committed to protecting lake, the watershed, and the surrounding lands.

The Acworth Selectmen referred the proposal to the Acworth Conservation Commission. The commission discussed the importance of the property to Crescent Lake, the Cold River watershed, and the town, and voted to aggressively pursue the acquisition. There are many questions and concerns that need to be addressed. Foremost and most obvious is funding. The final decision regarding the property is required by statute to be brought to a vote by the town. If the Conservation Commission determines that purchasing the property is recommended, our goal is to have an article ready for the March 2010 town meeting.

Acquiring this property would likely benefit all Crescent Lake property Over the last couple of years we owners by protecting our watershed and keeping valuable acreage from development, so we want to keep property owners informed. - \* 7/5 The aforementioned CLA meeting adjourns at 11:00 am! (More on back page)


